ANNUAL MEETING MINUTES

The Business meeting was called to order on the afternoon of January 25, 1999 by John Prentice president. One hundred forty three people attended the annual meeting, of them 124 were professionals and 15 students. The total Chapter membership is 246 with a breakdown of 215 professionals and 31 students. Each of the committee chairs present presented a report on the activities of their committee. Of special note was the Issues Committee which brought SB 1 to our attention, information will be made available to the membership at large on the bill.

There were three continuing education classes taught at this year's annual meeting with 66 participants. There were twenty-five presenters at the meeting and four posters which is an excellent turnout.

The Publicity and Exhibits committee headed by Steve Poarch had over \$7,000 worth of prizes and services donated to the Auction and raffle which went very well.

Special recognition was made to Tim Bonner for the "Outstanding Paper" at last year's meeting, Pat Hutson received a "Special Recognition in Fisheries Work" for his many years with Texas Parks and Wildlife Department, Loraine Fries was recognized for her work in "Administration of the Genetics Laboratory"

Charlie Munger was elected president elect and Deborah Wade as Secretary/Treasurer. Paul Hammerschmidt was installed as President.

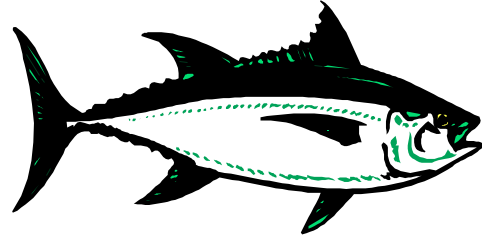

New Business:

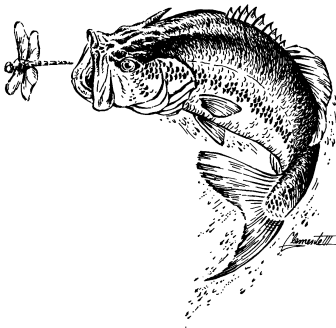
The major topic of discussion under new business was the 2000 meeting. It will probably be a joint meeting with Arkansas and Louisiana in January.

AMERICAN FISHERIES SOCIETY 1999 ANNUAL MEETING

Your invited to attend the 129th Annual Meeting scheduled for 29 August-2 September at the Adam's Mark Hotel in Charlotte, North Carolina. This years theme is "Integrating Fisheries Principles from Mountain to Marine Habitats". Featuring more than 20 symposia and hundreds of paper presentations. LIVE SHELL HARVEST RAISES CONCERN AMONG MARINE RESOURCE MANAGERS

Reports of the unregulated harvest of live shells from the marine environment have caused concern recently among fishery resource managers in Texas. The harvesters are as diverse as the uses of the live shells they collect and according to reports, they are collecting large numbers of live animals.

In the South Padre Island area, the collection of live shells from the shallow water flats has become popular among winter Texans. This is particularly the case in unique and easily accessible black mangrove stands where species such as lightening whelk, banded tulip, nerites, horse conchs, and others are found. These live animals are removed from their shells and disposed of with only the shell kept for use.

Along other coastal areas, collectors that are often recognizable along ethnic lines are harvesting marsh periwinkles from *Spartina* marshes for culinary

purposes. Whether the aquatic products are harvested for personal or commercial gain is often unknown and information on landings is very limited. It is possible, however, that heavy localized harvesting may have an impact on the population of some of the species in certain areas.

Currently, recreational harvesters are required to have a valid sport fishing license and a saltwater fishing stamp. Commercial harvesters must have a general commercial fishing license to sell the animals. A soft spot exists in the rules; however, which allows for the selling of parts of an animal collected under a sport license. For example, a crafter of seashell sailing ships or seashell Chihuahuas with googely eyes made from live shell collected under a sport license is not prohibited from selling their products.

Resource managers with the Coastal Fisheries Division of the Texas Parks & Wildlife Department will be investigating this fishery to determine the need for a fishery management strategy including possible regulation. The development of a management strategy may be an interesting process because of the diversity of those involved in the fishery.

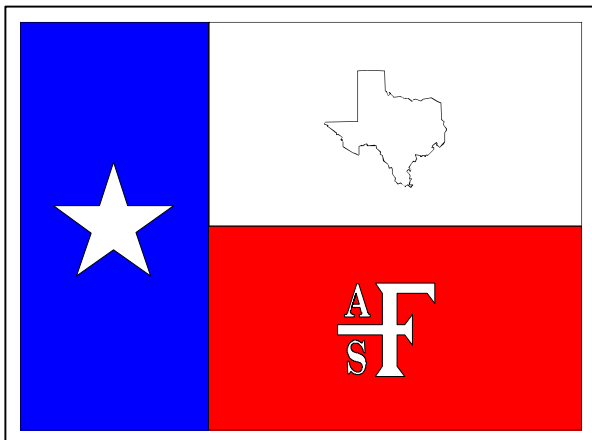
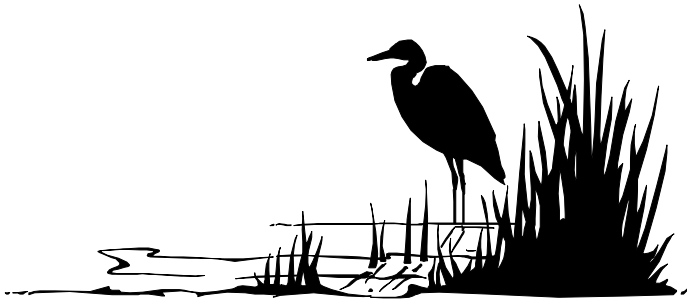

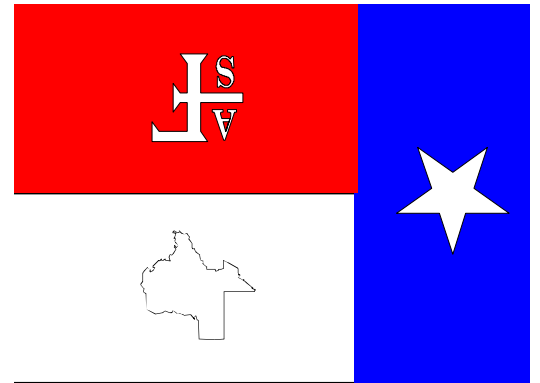
